**Cost Recovery for Professional Consulting Services, Including City Attorney Services**

For any activity requiring professional consulting services, including City Attorney services, the applicant shall reimburse the City for actual costs incurred to employ professional consulting services. The Department Director shall determine the appropriate deposit to be submitted by the applicant for recovery of professional consulting services.

**Initial Fee**

Applications identified by "Initial Fee" means that applicants will be billed for the full cost of processing the application based on staff time and materials over and above the amount of the initial fee. The initial fee covers one round of review, noticing and a public hearing. Projects which require multiple rounds of review or additional hearings will be billed for the additional time and materials based on the Planning and Building Hourly rate plus the General Plan Surcharge (see below).

**Development Review Services**

For services requested of City staff for which no fee is listed in this Master Fee Schedule, the Community Development Director shall determine the appropriate fee, based on the following hourly rates for staff time involved in the service or activity:
